STC COURSE LESSON PLAN

Course Title: Human Trafficking

Course Hours: 4

Course Summary: (Brief description of the course) This course will provide probation officers with the basic knowledge of Human Trafficking (HT), and the different types of HT, including the sex trade, sexual exploitation, organized prostitution, labor trafficking, and indentured servitude. Laws and statutes relating to HT, how probation investigations and supervision are affected by HT, victimology and surviving HT, County protocols, and resources for officers and victims. The course will include responsibilities of officers, how to identify, and how to proceed when suspected. Common trends will be discussed. A combination of slides, videos, and lecture will be used with time provided for questions and answers. Handouts and references will be given out to students.

Performance Objectives: (What the trainees will be able to do at the conclusion of the course.)

At the conclusion of the course, trainees will be able to: identify possible human tracking victims and suspects, have the knowledge of how to proceed with initial interview, and referral out according to County protocol. Students will also have basic knowledge of the human trafficking (HT) laws and prosecution, as well as knowledge of resources to assist in case management and treatment. Students will understand how to supervise a victim of HT and how it changes the dynamics of the supervision.

Trainees will be able to identify Human Trafficking and varieties of HT

Trainees will be able to identify recruitment, common culture and language used in HT.

Trainees will understand the power of coercion

Trainees will understand victimizers, how they operate and why

Trainees will know resources, and protocols of who to call for assistance in suspected HT situations and apply it to their role at probation

Trainees will understand victimology of HT and Trauma Informed Care and apply it to their caseloads

Trainees will understand the laws governing HT and how it relates to their caseload handling

Trainees will understand CSEC and laws relating to minors in HT and their duties as probation officers

Trainees will have a knowledge of the SLO HT Task Force make up and purpose
