1. <u>Introductions and roll call</u>

Chair calls the meeting to order at 1:30 PM and a quorum is established. Introduction of attendees.

2. Approval of April 13, 2022 meeting minutes

- W. Peterson introduces the item.
- C. Mulholland comments that she has no amendments to offer.

The Committee approves the April 13, 2022 meeting minutes (5-0-0)

3. Fiscal Year 2022/23 Budget Presentation

- B. Clark introduces the item and J. Johnson presents on the Budget for the 2022-23 Fiscal Year.
- W. Peterson asks about Stream Data Management item on the budget. B. Clark answers.

^{*}Attended (virtually by Zoom):

- W. Peterson asks if all rainfall data are being saved and preserved. B. Clark confirms.
- C. Mulholland comments on confusion between commas and periods in the budget document. B. Clark responds.
- C. Mulholland comments on the figures for Maintenance Recording Data Gauges and County Area Veg. Maintenance line-items and asks why the numbers are much higher for the upcoming fiscal year. B. Clark responds.
- B. Nelson asks about revenues and financing sources. B. Clark and J. Johnson responds.

4. Endorsement of the City of San Luis Obispo's Annual Work Plan – Fiscal Year 2023-24

- B. Clark introduces item and B. Nelson and F. Otte presents on the City's Zone 9 Budget Request for the 2023-24 Fiscal Year.
- C. Mulholland clarifies if the budget request for Silt Removal is on top of the existing funding and asks how we ended up with money unspent from last year for Silt Removal if we have a \$0 budget every year. B. Clark responds. B. Nelson adds to response.
- B. Clark states that the General Creek Maintenance funds, in contrast to the Silt Removal funds, resets every year and does not carry over.
- J. Hall asks what date the County's fiscal year starts. B. Clark responds.
- B. Nelson states the Mid-Higuera Bypass Project is still at 90% design and the City currently has one permit from the Water Quality Control Board and are waiting for a couple more permits to come in. C. Mulholland asks when the permit would expire, and B. Nelson responds.
- B. Nelson states the project could begin construction in the dry season of 2024 pending design completion, permit approvals and easement agreements. Additional information regarding project costs, DWR grant, and the Zone 9 funding request for 2023-24 fiscal year is given.
- W. Peterson asks if the City has talked to the County about the funding availability. B. Nelson responds.
- B. Clark adds the city has submitted this funding request under the existing City-County agreement and would potentially not require a new agreement if approved.

W. Peterson asks if next year we would be looking at multiple requests and approvals that would include this new maintenance related project work. B. Clark responds.

Motion by: Christine Mulholland, to take the Budget Request by the City, as Presented to the Board of Supervisors.

Second by: Carlyn Christianson

J. Hall asks if it is appropriate for him to abstain from voting because they receive funding through the City for Zone 9 efforts. B. Clark responds.

Motion to have the budget request presented to the Board of Supervisor passes. (4-0, J. Hall abstains)

8. Ongoing Updates

a. Mid-Higuera Bypass Project

- B. Nelson states one permit has been issued so far. The City is making progress on securing easements and have received appraisals for multiple properties and if everything go as planned, advertisement for construction will begin next fall.
- W. Peterson comments on the permit fee refund. B. Nelson and F. Otte responds.

b. Creek Maintenance

- F. Otte comments on the creek maintenance efforts at the Marsh Street Bridge and at different locations along Stenner Creek and Prefumo Creek.
- B. Clark comments on an extreme flooding that occurred at the intersection near the Prefumo Creek area in 1995.
- F. Otte shares the City has been in contact with Cal Trans and Chevron to let them know that they are responsible for maintaining the Prefumo creek areas within their properties.
- C. Mulholland comments on flooding on freeway around LOVR back in 1969 or 1973 and asks if the work we are doing now will help alleviate flooding in the area once we have another wet year. F. Otte responds.
- W. Peterson comments that the portion of creek from LOVR North to Prado Road used to be a third of the size it is today.
- C. Mulholland expresses concern that to this day, a portion of LOVR experiences overflow from the creek even with smaller storm events. W. Peterson and F. Otte responds.

- F. Otte comments on City and County's efforts in East Fork SLO Creek and states the California Conservation Corps will be coming out for three weeks beginning October 17th to carry out flood control activities. The City and the County has secured all necessary right-of-entries except for one for the Thousand Hills Pet Resort. W. Peterson offers to speak to owner of the pet resort if needed. B. Clark responds.
- B. Clark and F. Otte explains the scope and goals of the East Fork Creek Maintenance project.

c. <u>Arundo Removal</u>

- J. Hall comments that work has begun and states they now have access to areas upstream of LOVR that they haven't been able to before due to homeless encampments. However, the stretch of creek near Octagon Barn is no longer accessible for the same reason. Two areas remaining that aren't currently under treatment are at LOVR Bridge and See Canyon due to permitting and scheduling conflicts.
- B. Clark asks if it is a possibility to try to do Arundo removal together with the County's vegetative maintenance in the future. J. Hall responds.
- F. Otte comments he has been in contact with personnel from the California Department of Fish and Wildlife (Linda and Julie) and will be doing quarterly calls to allow for better communication for future projects/maintenance efforts and ideally facilitate permitting process. J. Hall adds to comment.
- W. Peterson comments on the permitting process. J. Hall and F. Otte responds. There is additional roundtable discussion regarding permitting.

d. <u>East Fork Limited Study</u>

- B. Clark states that the study wasn't ready for review today and gives an overview on the consultant's findings from the modeling.
- W. Peterson comments on flooding at Vachell Lane. B. Clark responds.
- B. Clark comments on improving culvert maintenance in the East Fork area and other high-flood-risk areas in the future.
- B. Nelson asks if the study talks about maintenance downstream. B. Clark responds.

Subject: 2023-2024 Zone 9 Budget Request

Based on the current status and future needs to continue making progress on several projects, the City is requesting the following funding from Zone 9 for the 2023-2024 Fiscal Year.

Project Name	Requested FY 2023/24
General Creek Maintenance	\$183,500
General Creek Maintenance in County Areas	\$60,000
Silt Removal	\$150,000
Mid Higuera Bypass	\$1,400,000
Total	\$1,793,500

General Creek Maintenance

\$134,500 to fund ongoing general creek maintenance which includes channel clearing, including removal of trees, vegetation, and arundo from creeks. Funding is planned to be used as follows:

1.	Contract Labor - Channel Clearing:	\$100,000
2.	Channel Tree Removals:	\$50,000
3.	Vegetation Disposal:	\$ 5,000
4.	Arundo Removal:	\$28,000

General Creek Maintenance in County Areas

\$60,000 to fund ongoing assessment and maintenance of creeks and waterways that come into or leave the City and cross County jurisdictional area. This will be an expansion of the existing work program the City currently undertakes in City-limits. Prioritization will be completed where flooding or backwatering has occurred in the past to ensure proper drainage exists. Funding is planned to be used as follows:

Creek Assessment and Mapping: \$3,000
 Contract Labor/Tree Contractor - Channel Clearing: \$52,000
 Vegetation Disposal: \$5,000

Silt Removal

Existing funding to support Silt Removal is approximately \$130,000. Each year City staff assess several creek locations for silt accumulation and focus future projects in the areas that have the highest benefit to the creek system. The existing funds, in addition to the requested appropriation of \$150,000, will support design surveys, permitting work, and silt removal construction work at locations selected for a project in Fall 2023. Typically, yearly silt removal projects address 1-3 locations, with the construction cost directly related to the volume of silt removed and ease of access for construction equipment. In 2023, staff are planning to perform silt removal at up to five locations.

Mid Higuera Bypass

Mid-Higuera Bypass project is currently at a 90% design completion. County Staff have submitted for environmental regulatory permits and have so far received a Regional Water Quality Control Board Section 401 permit. The design will be finalized once the remaining environmental permits for Army Corp and Fish and Wildlife are received.

Pending final design completion, permit approvals, and final property easement agreements, the project could begin construction within the 2024 calendar year. The City was awarded a \$6 million DWR grant for the project, but the total project cost is underfunded by an estimated \$4.3 million, largely due to inflationary construction cost escalation of approximately 37% since estimates were last produced (per California DGS), with much of that increase occurring over the last year due to shortages in labor and materials and increases in fuel costs. Total project costs include construction, construction management/engineering and environmental compliance, easements, and construction contingency.

This funding request is for maintenance related project work included in the Mid-Higuera Bypass project scope, including:

- Removal of invasive plant species
- Tree pruning and tree removals
- Removal of trash and other debris in creek channel
- Silt Removal at Marsh Street Bridge
- Plantings and plant establishment
- Construction phase design support and environmental services

The estimated costs of the above work scope including contingencies is approximately \$1.4 million.

SUBJECT: Mid-Higuera Bypass Project Updates

<u>Update</u>

During September 2021, the County of San Luis Obispo Water Conservation and Flood Control District (District), in coordination with the City of San Luis Obispo (City), applied for several permits in compliance with the provisions of the Clean Water Act and provided responses in February 2022 to initial requests for information from the following agencies:

California Department of Fish and Wildlife (CDFW), Section 1600

A response to CDFW's 8/26/22 RFI response has been prepared and the City has finalized their review – it will be submitted to CDFW by 10/7/2022. The County will had a meeting on 10/6 with CDFW and discussed the permitting and excessive, repetitive RFIs.

Army Corps of Engineers (ACOE), Section 404

ACOE is in consultation with the USFWS. On 9/26 the Corps forwarded on a USFWS question regarding 3:1 mitigation ratio and if there is sufficient space to mitigate replacement plantings at this ratio. We will resolve the question by 10/7. A copy of the 401 permit was forwarded to the Corp.

Regional Water Quality Control Board (RWQCB), Section 401

This permit was issued 9/22/22. We will receive a \$13,442 permit fee refund.

The City is making progress on securing permanent easements and temporary construction easements. So far the City has received appraisals from Hamner, Jewel and Associates for work impacting the Madonna Property west of Bianchi Bridge and the Todd Property adjacent to Mathews open space where channel widening will involve removal of an existing structure on the Todd property. The City has also received a third appraisal for the Hayes property, which is adjacent to Todd.

On July 19th, City staff received negotiating authority from City Council to begin formal negotiations with the Madonna and Todd properties. Staff will return to Council for negotiating

authority for the other affected properties once all appraisals are received, which is expected to occur by the end of 2022.

Additionally, City and County staff are pursuing a negotiated funding arrangement for the unfunded portion of the project construction phase. In May, City staff transmitted a formal letter request for funding support to County Staff.

Wallace Group's remaining final design work continues as follows:

- Topographic survey on Bianchi to capture development improvements (completed)
- Legal descriptions for property negotiations (in progress, nearing completion)
- Utility letters and coordination (in progress)
- 95% PS&E revisions (pending Jurisdictional permit review and comments)
- Right of entry and construction easement exhibits (completed)
- Building Permits: Grading and Demolition plan for building removal (pending approval and agreement of Todd property easement acquisition)
- Final 100% contract documents (pending)

SUBJECT: Creek Maintenance Updates

Most of the creek survey work has been completed and the hot spot/pinch point areas have been a focus for this effort. Marsh Street Bridge at the Promontory has been cleaned up and dead material has been removed from the channel. This location is critical due to it being the confluence area for both SLO and Stenner Creeks immediately downstream of downtown. Murray and Santa Rosa Streets over Stenner Creek has received maintenance since we have experienced flooding from this location in the past as well. Additional surveys in Stenner Creek up to Foothill Blvd still needs to occur but the area around the Foothill Bridge needs to be evaluated for the number of trees in the channel that may impede flow in the future. Stenner Creek from Chorro down to Broad Street has some debris from the businesses but City staff is following up on that. Additional projects have been identified in lower Prefumo Creek before it enters Laguna Lake (minor trimming of dead material near the channel), trimming of aquatic vegetation at the outlet of Laguna Lake and other dead trees in the channel in Prefumo Creek downstream of Laguna Lake that will be removed with contractor help.

City/County efforts in East Fork SLO Creek will kick off with the California Conservation Corps coming out to assist with flood control activities for three weeks beginning October 17th.

SUBJECT: Arundo Removal Updates

Work has begun and survey/control work is progressing from the upstream extent of the watershed to Los Osos Valley Road (LOVR). The homeless camps upstream of LOVR have been vacated allowing access to populations not accessible in previous years. However, those encampments have moved south of the Octagon Barn and that stretch of creek is now inaccessible due to safety concerns. We are also beginning outreach to the See Canyon watershed that drains into San Luis Creek and historically contains previously untreated populations of Arundo. The Large population at the SLO Creek and LOVR intersection is currently on hold due to permitting delays and CCC scheduling conflicts due to Fire Season needs taking precedent.

SUBJECT: East Fork Limited Study Updates

Since the consultant presentation at the December 8th, 2021 meeting, the East Fork Study has experienced significant delays due to staff turnover at both the County and the consultant, Schaaf and Wheeler. County staff has been working closely with Schaaf and Wheeler to refine the models, discuss CIP opportunities, and more.

Findings from the study are starting to solidify.

Existing conditions:

- Flooding in less than 10-yr interval
- Backwater conditions are primary cause of flooding conditions. Area between Buckley and SLO Creek @ S. Higuera is incredibly flat.
- Buckley road Culvert is very sensitive to clogging increased maintenance will help.

Future / Near-term Conditions

- Buckley Road extension appears to have improved flood conditions for Buckley & Vachell.
- Upstream storage improvements (i.e. near airport) would be modest.
- Channel widening below Buckley Road appears to have the most effect at reducing flooding in the area.

We expect a draft report to be completed ahead of our December 7th meeting for Committee review.
